	c)	Example: SOLAS SOLAS sets minimum standards for things like the number of lifeboats required per ship, the kinds of communication equipment required onboard to aid in rescues and the planning of shipping routes that the Pacific Adventure would have to comply with. The safety drill passengers		

must attend on the first day of a cruise is one of the more **visible** requirements for the Pacific Adventure set forth by the SOLAS treaty and overseen by the country whose flag the Pacific Adventurer flies under.

### Individual Cruise line policy: P&O

P&O cruise ships have contingency plans which are designed to handle shipboard emergencies with immediate and effective support. In case of an actual emergency, P&O ships are equipped with life jackets, lifeboats and emergency supplies for every guest and every crew member on board. In addition, all the ships are equipped with emergency location lighting and broadcast communication equipment, including the Global Maritime Distress Safety System (GMDSS).

A significant portion of P&O employee training program content is dedicated to the prevention of shipboard accidents. Any injury sustained by a shipboard employee or contractor must be reported according to P&O guidelines, whether it occurs during working or rest hours, on board the ship or during shore excursions.

Small ship cruising	a) Identify two small ship companies offering cruises in and around Australasia.  Examples include Silversea Cruises (Owned by Royal Caribbean Group) or Coral Expeditions, Blue Lagoon Cruises and Island Escapes  b) Example: Silversea Cruises: Silver Muse 15-day cruise catering for up to 596 guests. Sydney embarkation to Auckland disembarkation – ports of call include Tasmania, Milford Sound, Doubtful Sound, Dunedin, Akaroa, Picton, Wellington, Gisborne, Tauranga. Standards of Training, Certification and Watch keeping for Seafarers Code (STCW).

The regulation of training under STCW helps in the improvement of working standards. Cruise vessels employ professionals at every rank only with the minimum STCW qualifications. It means every crew person on the Silver Muse has sufficient training for basic emergencies like a fire, collision, and medical cases. The STCW 2010 also controls updating the crew's knowledge with refresher courses. These modules make sure that each staff member on the Silver Muse is aware of the industry's safety standards.

### NZ Maritime Rules: Rule 31 Crewing and Watchkeeping

This rule sets out requirements relating to the minimum crew numbers and crew certificates and qualifications that Silver Muse needs to comply with. It also provides for a process for the issue of Minimum Safe Crewing Documents. This Part also sets out requirements relating to fitness for duty, prescribed hours of rest, and watchkeeping that will apply to the Silver Muse (these rules are in accordance with the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers) (STCW)

#### QUESTION THREE

Short itinerary vessels providing short scenic cruises, fishing charters and thrill rides.

Example:

a)

Shotover Jet Boating Adventure Ocean Dream Fishing Charters Southern Wanderer Scenic Cruises Real Journeys a) Identify **three** companies offering short itinerary experiences in New Zealand – **one of which must be a company offering jetboat thrill rides**.

b)	Example: Shotover Jet Operates on the Shotover River, located less than 10 minutes' drive from central Queenstown, provides thrill jetboat ride through dramatic and narrow Shotover Canyons. The award-winning Shotover Jet is an exciting jet boat ride, operating at high speeds and delivering gravity-defying stunts to thousands of visitors every year. These unique qualities combined with the stunning setting of the Shotover River provide passengers with adrenaline filled fun Jet Boating adventure.  Ocean Dream Fishing charters are available for fishing the Waitemata Harbour & Hauraki Gulf. MV Princess Carol was imported to New Zealand from Australia and is virtually a brand-new vessel. At 14.55m & running twin 500 h.p. Cummins diesel engines the boat cruises at over 20 knots, offering faster travel to fishing grounds. The luxury euro styling interior is complemented by its functionality & superb finish. Company is surveyed by Maritime NZ to entertain up to 20 day guests with a crew of three. Can comfortably fish 10 people at any one time. Also, able to accommodate up to 6 guests overnight in three double cabins, with 2 bathrooms including hot showers.	Select two of the identified companies – one of which must be a company offering jetboat thrill rides - and for each company describe one of the experiences that they have to offer. c)

These rules are intended to limit the likelihood and consequences of serious harm to people on board commercial jet boats operating on rivers such as the Shotover Jet on the Shotover River. It sets safe design and construction standards for jet boats, sets standards for safety equipment, and establishes safe operating procedures that must be followed by commercial jet boat operators and drivers such as Shotover Jets.

The rules also require drivers to hold a New Zealand Commercial Jet Driver (River) Licence and to meet the competency requirements of the operation in which they drive. MNZ regularly inspects jet boats and safety equipment, and audits operations to ensure continued compliance with Part 82 requirements.

A Commercial Jet Boat Operator Certificate is evidence of continued compliance and must be displayed in a prominent position at a commercial jet boat operation such as Shotover Jets.

Explain how the maritime rules for commercial jetboat operations apply to your selected company offering jetboat thrill rides.

## QUESTION FOUR

Ferries and water taxis

Identify **three** ferry companies that operate in New Zealand.

	Bluebridge ferries travel regularly between the North and South islands and can transfer vehicles, motorcycles and pets. Comfortable seating, lounges with Wi-Fi and dining options are available onboard, so are private cabins. Sailings start in the morning and run through into the evening with increased sailings in summer. Bluebridge's offer overnight sailings with their private sleeper cabins when sailing from Wellington to Picton. This is an economical and comfortable way to travel and is suitable for families.	Select <b>one</b> of the ferry companies and provide information on the location, facilities and services offered.
c)	Administered by Maritime NZ HSWA sets out a framework of duties for businesses, senior leaders of businesses, workers and other people who might be present in the maritime workplace. Some duties are set out in more detailed regulations that control particular hazards or types of maritime workplaces. Businesses and workers must take reasonably practicable steps to manage health and safety risks. The framework of duties is designed to make owners and operators responsible for the safe operation of their vessels, protect the marine environment and ensure the safety of the vessel and its crew. Regular health and safety meetings and training is one way of managing under HSWA as is identify and mitigating vessel operation and maritime hazards.	Explain how the HSWA applies to companies operating water transportation vessels such as ferries and water taxis in New Zealand. (Minimum 80 words required).
