 Officer. An initial meeting was held to confirm the brief but no further meetings since then.
- Dates were agreed with the website developer. The developer has reported that these cannot be met. This is not a failure of the quality assurance processes, as regular progress against timeframes have still been met
- There is a budget overrun. Again, the quality assurance process has not failed as this overrun has been identified.
