### Marking Guide – Task 1

Students must present their work for this task by submitting one (1) journal post of between 800-1000 words and contain references to the following:

1. the potential for integrating research findings in their work

2. proposals of research outcomes to business practice considerations

3. a discussion of the connections and associations between history, theory, and contemporary practice

4. specify how research impacts their professional practice

Assessor Instructions: Students must detail the above in no less than 800-1000 words.

### 1. Determine the potential for integrating research findings into your creative work, including the completion of the table [200-250 words]

### Include the following:

- o Discuss your understanding of what constitutes design history and cultural history
- o Detail your understanding of the benefit of using research findings in your work
- Provide evidence of four (4) from the eight (8) ways detailed below, how you have linked theory and practice in this module (Detail your sources and the definition of each (theory) and the usefulness to your practice (outcome) using the table provided. Use the drop-down menu to specify your choice. (Include the table in your reflection).

**Assessor Instructions:** Student responses will vary; however, the response must contain the main issues and ideas evident in the development of visual communication required for the first section of task 1. A sample answer is detailed below.

The word count for this response must be between 200-250 words, which includes the completion of the table provided

- Students need to write in the first person
- An investigation of the main issues and ideas in the development of visual communication needs to be evident
- This is a good example of what to look for in this task. Evidence should include the following:
  - Students must define design history:
    - It is the study of objects of design in their historical and stylistic contexts. With a broad definition, the contexts of design history include the social, cultural, economic, political, technical, and aesthetic
  - o Students must define cultural history:
    - It is the study of everyday life, experiences, values, and norms, plus attitudes, values, assumptions, and prejudices that members of society hold – either consciously or subconsciously
  - $\circ\;$  Students must discuss the benefits of using research findings in their creative work. For example:
    - Research skills have helped me to find information on my chosen company and use it effectively. This includes creating a strategy to gather facts and reach conclusions so that I can answer questions
    - I have used a mind-mapping document that has helped me investigate alternative ways of looking at an assignment in a creative context
    - I recognise that my skills are highly transferable and can be adapted to many settings
    - Thinking about a specific topic, reading broadly, finding relevant information, and evaluating sources have been applied to my creative work effectively

**Assessor Instructions:** Student responses will vary; however, the response must reference visual communication history and theory and research outcomes to business practice considerations. A sample answer is detailed below.

- The word count for this response must be between 200-250 words, which includes the completion of the table provided
- Students need to write in the first person
- An evaluation of how visual communication history and theory research outcomes to business practice needs to be evident
- This is a good example of what to look for in this task. Evidence should include the following.
  - Students must discuss the definition of what constitutes research outcomes (visual communication history and theory) in their work. For example:
    - It is the study of how designers use visual elements to communicate in both historical and contemporary contexts
    - Visual communication history and theory is a branch of communication studies that focuses on the way that visual information is processed and used to transmit messages
  - Students must discuss what constitutes visual communication business practices in the industry. For example:
    - Visual communication theory can be broken down into two (2) main categories
    - Visual representation deals with how visual elements are used to represent information
    - Visual communication is about the actual sending and receiving of messages through visuals
  - Students must provide individual responses, which can include:
    - I have looked at how it is applied in industry to any type of image, from advertisements, campaigns, websites, and social media posts
    - I have made informed choices about my design outcomes rather than just relying on aesthetic considerations
    - My research in the industry has covered everything from how I can use visuals to convey meaning and how to use them to improve my work
- Students must provide evidence of five (5) ways their research outcomes and business practices have been maintained in their work for this module and needs to be specified in the following table. Students must choose five (5) sources in their responses. Column 1 has been supplied, and column 2 needs to be selected from a drop-down menu.

**Assessor Instructions:** Student responses will vary; however, the response must detail how the critical views of others have informed the student's research in this third section of task 1. A sample answer is detailed below.

- The word count for this response must be between 200-250 words, which includes the completion of the table provided
- Students need to write in the first person
- Critical viewpoints of others that have informed the student's research strategy need to be evident
- This is a good example of what to look for in this task. Evidence should include the following.
  - Students must discuss their work's definition of history, theory, and contemporary practice. For example:
    - History and theory are often interlinked but can mean very distinct activities
    - History is the study of past events
    - A theory is a type of thinking about a theme or a subject but can be more specific depending on the subject matter
    - Contemporary practice is up-to-date responses in exploring and incorporating new technologies
  - Students must provide individual responses, which can include:
    - I recognise through experience that the best approach to evaluate my work is to do it in a structured way
    - I have used it in my creative and written outcomes, including my research into my chosen company, encompassing history, theory, and contemporary practice
    - This has enabled me to learn from what I have done in my work and apply this and be more successful in the next project
    - There is an opportunity for reflection to become more central to my practice by asking questions and thinking critically about my ideas
    - There are benefits to becoming a reflective practitioner, and these will need to be practised so that it becomes second nature to evaluate my written and designed outcomes
- Students must prove how history, theory, and contemporary practice have been maintained in their work for this module.

- A discussion of how the analysis of how research has impacted the student's professional practice and ideas for future development in this area needs to be evident
- This is a good example of what to look for in this task. Students should include the following,
  - Students must discuss what research and professional practice are in their work. For example:
    - Research is the creation of new knowledge in a new and creative way and specific to the task or assignment in question
    - Professional practice is where I can extend my knowledge gained through research and applied to a practical environment
  - Students must detail how their research skills have improved over the course of this module, which can include:
    - I began with researching broadly into my company, and I got to know the topic in some detail from my research sources
    - I used quality, reliable sources, which were evident in my bibliography
    - I organised my research into sections which I then applied to the specific points that I used to complete my investigations
    - *My research skills have improved, and I can practice and refine these by researching other topics during other modules*
    - I feel more confident in my research skills because of completing this module
- Students must provide evidence of how research has impacted their professional practice and how this approach and connection can be sustained in their work for this module.
